

TERMS AND CONDITIONS

Card Usage Campaign in collaboration with Alpan Group Limited (Electroline)

1. Eligible to participate in the card usage campaign in collaboration with Alpan Group Limited ("Electroline") (the "Campaign") are holders of personal Visa and/or Mastercard debit and/or prepaid and/or credit cards (the "Cards") issued by Bank of Cyprus Public Company Ltd (the "Bank"), who (a) have reached eighteen (18) years of age at the time of their participation in the Campaign (the "Cardholder(s)"), and (b) have used their Cards at Electroline in Cyprus, either in-store or online via www.electroline.cy, for the purchase of any laptop computer during the period from 19/08/2026 up to and including 05/10/2026 (the "Transaction") (the "Participants").
2. The first five hundred (500) Participants who complete the Transaction, in chronological order and on a first-come, first-served basis (the "Beneficiaries"), will receive a promotional code (the "Promo Code") worth 5,000 points (equivalent to €50) under the Bank's Antamivi Card Reward Scheme.
3. The following are excluded from this Campaign:
 - (a) Holders of business cards.
 - (b) Holders of cards that are linked exclusively to accounts in a foreign currency (i.e. currencies other than euro).
4. The Campaign will be valid from 19/08/2026 up to and including 05/10/2026.
5. The distribution of the personal Promo Codes shall be carried out exclusively by Electroline. More specifically, Electroline will send each Beneficiary their personal Promo Code within twenty-four (24) hours from the time the Transaction is completed for in-store purchases, and on the next working day for purchases made through Electroline.cy. The Promo Code will be sent either by SMS to the mobile phone number and/or by email to the email address provided by the Beneficiary to Electroline in connection with the purchase made for the purposes of this Campaign or in connection with previous purchases. Accordingly, the Bank shall bear no responsibility whatsoever for the distribution, delivery, non-delivery, availability, or proper operation of the personal Promo Codes, as the relevant process is carried out solely and entirely by Electroline.
6. To receive the 5,000 antamivi points, the Beneficiary must enter their personal Promo Code in the antamivi application (antamivi app) under the "Coupons" section by selecting the "+" icon displayed on the right-hand side of the screen and following the relevant instructions that will appear within the application. It is understood that the Beneficiary must have already installed, or install at that time, the antamivi application (antamivi app) on their smart device in order to complete the process of obtaining the 5,000 points no later than 05/11/2026.
7. The 5,000 antamivi points that will be credited to each Beneficiary through the Promo Code, provided that they have completed the process described above, may be redeemed by the Beneficiary at any merchant participating in the Bank's Antamivi Cards Reward Scheme.
8. Each Participant is entitled to receive only one (1) personal Promo Code, regardless of the number of laptop computers purchased from Electroline during the Campaign Period.
9. If, for any reason, any part of the Campaign cannot operate as planned, including, but not limited to, computer virus infection, network unavailability, unauthorized intervention, fraud, technical failure, or any other cause that compromises or affects the security, integrity, or proper conduct of the Campaign, the Bank reserves the right to cancel, terminate, modify, or suspend the Campaign, or to invalidate any of the affected entries/participations.

10. In the event that a Cardholder terminates the account associated with their Card, through which the Cardholder participates in the Campaign, the Cardholder will be eligible to participate in the Campaign only if the Transaction was processed prior to the closure of the said account.
11. The Bank reserves the right to cancel the Promo Code and, consequently, the award of antamivi points in the event of the cancellation, reversal, chargeback, or refund of the Transaction.
12. The Bank and Electroline shall not be liable for the loss, deletion, non-receipt, or non-use of the personal Promo Code by the Beneficiary for any reason beyond their reasonable control.
13. The Campaign is valid irrespective of any other offers or promotional activities of Electroline, unless otherwise stated in the relevant offer or promotional activity.
14. The Campaign is conducted in cooperation with Electroline, which participates in the Bank's Antamivi Cards Reward Scheme.
15. The Bank may disqualify any participation and prevent any further participation in the Campaign by any Cardholder / Participant / Beneficiary who, in any way, interferes with the participation process or the proper conduct of the Campaign, or who acts in violation of these Terms and Conditions.
16. The Bank reserves the right to amend these Terms and Conditions at any time by providing notice to the Cardholders / Participants / Beneficiaries.
17. To the fullest extent permitted by law, the Bank shall not be liable for any loss, injury, or damage to any person or property that may arise, directly or indirectly, wholly or partially, from participation in the Campaign and/or the use of the personal Promo Code and the related antamivi points.
18. The Bank makes no representations or warranties and provides no guarantees whatsoever regarding the laptop computers purchased from Electroline as part of the Campaign.
19. By participating in the Campaign, Participants warrant and confirm that they have read and understood these Terms and Conditions and agree to be bound by them.
20. These Terms and Conditions shall be governed by and construed in accordance with the laws of the Republic of Cyprus.
