

**TERMS AND CONDITIONS**  
**CARD USAGE CAMPAIGN IN COLLABORATION WITH ALPAN GROUP LTD**

1. Participation in the card usage campaign in collaboration with Alpan Group Limited (the “Campaign”) is open to the first 500 customers, on a first-come, first-served basis, who are holders of personal Visa debit, prepaid and/or credit cards (the “Cards”) issued by Bank of Cyprus Public Company Ltd (the “Bank”), who have reached the age of eighteen (18) at the time of participation in the Campaign (the “Cardholder(s)”), and who use their Cards at Electroline stores in Cyprus (“Electroline”) for purchases amounting to €600 (six hundred euros) or more in a single receipt (the “Gift”) during the period from 06/07/2026 to 06/08/2026, inclusive (the “Transactions”).
2. During the Campaign period:

The first 500 Cardholders, in chronological order, will receive a voucher for one free Nespresso Vertuo Pop by De’Longhi coffee machine, which may be redeemed upon receipt at Electroline stores (the “Voucher”). The Voucher will be valid until 06/09/2026.
3. Holders of business cards are expressly excluded from participation in the Campaign.
4. The Campaign will run from 06/07/2026 to 06/08/2026.
5. A prerequisite for receiving the Voucher is the completion of a transaction with a total value of €600 or more, using Visa cards issued by the Bank and held by the Cardholder (debit and/or prepaid and/or credit cards), for purchases made at Electroline stores (physical and online stores) during the period from 06/07/2026 to 06/08/2026, inclusive.
6. The Voucher will be issued automatically and will appear in the respective eligible customer’s antamivi application (the “Beneficiary”). To redeem it, the Beneficiary must install the antamivi application on their smart device and present the Voucher at any Electroline physical store in order to complete the collection process for the Gift. The Voucher will be available for redemption until 6 September 2026.
7. The Voucher may be redeemed exclusively in person at Electroline stores by presenting it at the checkout counter.
8. The Bank reserves the right to exclude any participation and to disallow further participation in the Campaign by any Cardholder who interferes in any way with the participation process or the proper operation of the Campaign, or who acts in breach of these Terms and Conditions.
9. Each Cardholder may receive the Voucher once only.
10. By participating in the Campaign, participants confirm that they have read and understood these Terms and Conditions and agree to be bound by them.
11. In the event that a Cardholder terminates the account associated with their Card, the Voucher must be redeemed prior to the cancellation of the Card.
12. The Voucher and the Gift may not be exchanged for any other prize, gift and/or any other product available at Electroline stores. The Voucher and the Gift are provided solely and exclusively in connection with this Campaign.

13. Any expenses, charges or taxes that are not expressly stated in these Terms and Conditions or in the description of the Gift, and which may arise from the acceptance, possession or use of the Gift, shall be the sole responsibility of and borne exclusively by the Beneficiary.
14. The Bank reserves the right to amend these Terms and Conditions at any time, subject to prior notice being given to the Cardholders.
15. The Bank makes no representations or warranties of any kind and provides no guarantees whatsoever in relation to the Gift.
16. To the fullest extent permitted by law, the Bank shall not be liable for any loss, injury or damage to any person or property that may arise, directly or indirectly, in whole or in part, from the acceptance, possession or use of the Gift.
17. These Terms and Conditions shall be governed by and construed in accordance with the laws of the Republic of Cyprus.
