

TERMS & CONDITIONS Jumbo Cyprus Xmas Campaign 2025

- 1. All customers who hold personal credit cards Visa and/or Mastercard (the "Cardholder/s") issued by Bank of Cyprus Public Company Ltd (the "Bank") are eligible to participate in the campaign, provided they use the Bank's cards during the period from 01/12/2025 to 24/12/2025 for purchases at Jumbo Cyprus stores. They will benefit from a 10% discount (the "discount") at the time of payment, with a maximum discount amount of €20 (twenty euro) per Cardholder.
- 2. If a Cardholder uses part of the €20 discount amount on a single purchase receipt, the remaining amount may be used in a subsequent transaction, provided that it takes place within the campaign period.
- 3. For Cardholders to be eligible for the discount, they must make their purchases from a Jumbo store in Cyprus using a personal Visa and/or Mastercard credit cards issued by the Bank.
- 4. The discount will apply irrespective of any other current offers by Jumbo stores in Cyprus during the period of the campaign.
- 5. The discount applies only to purchases where the Cardholders are physically present in Jumbo stores.
- 6. For purchases made via the Jumbo Cyprus website, https://www.e-jumbo.cy Cardholders will receive 5x antamivi points, for a maximum of 2000 points.
- 7. The discount is in partnership with Jumbo Cyprus stores, that are participating merchants in the Bank's Antamivi Cards Loyalty Scheme.
- 8. All Cardholders of personal credit cards issued by the Bank who have already reached the age of 18 at the time of their participation in the campaign are eligible to participate.
- 9. This campaign excludes Cardholders who only hold cards linked to an account in a currency other than Euro.
- 10. The Bank may, at its discretion, disqualify any participant(s) and not allow further participation in the campaign to any individual who interferes in any way with the participation process or the smooth operation of the campaign or who acts in breach of these Terms & Conditions.
- 11. The Bank reserves the right to amend these Terms and Conditions at any time, with prior notice to the Cardholders.
- 12. To the fullest extent permitted by Law, the Bank shall not be held liable for any loss, damage or injury to any person or property that may arise, directly or indirectly, in whole or in part, from the acceptance of the discount.
- 13. The Bank does not make any representations or warranties, does not provide any guarantees with respect to any goods or services of the merchant participating in the Antamivi Scheme and does not give its approval in respect of any such goods or services.
- 14. By partaking in the campaign, Cardholders confirm that they have read and understood these Terms & Conditions and have agreed to be bound by them.
- 15. These Terms & Conditions shall be governed by the Law of Cyprus.
