

TERMS AND CONDITIONS FOR THE OLYMPIC / PARALYMPIC GAMES PARIS 2024

1. Eligible to participate in the campaign (the **"Campaign"**) are all holders [the **"Holders"**] of personal Visa cards (the **"Cards"**) issued by Bank of Cyprus Public Limited Company (the **"Bank"**) who will use their Cards for purchases from 22/5/2024 to 22/06/2024 inclusive and will take part in a draw where four (4) lucky entrants (the **"Lucky Entrants"**) will each get a chance to win one of four (4) packages for the Paris 2024 - Olympic / Paralympic Games (each package for two (2) people) as stated in paragraph (22) below (the **"Prizes"**).
2. Each transaction carried out with the Cards will correspond to one entry in the draw.
3. Eligible to participate in the Campaign are all Holders who are at least 18 years of age at the time of participating in the Campaign.
