

**TERMS AND CONDITIONS**  
**VISA CARD – Disney Paris 2026 CAMPAIGN**

1. Eligible to participate in the campaign (the “Campaign”) are all holders (the “Holders”) of personal Visa cards (the “Cards”) issued by Bank of Cyprus Public Limited Company (the “Bank”) who will use their Cards for purchases from 05/01/2026 to 20/02/2026 inclusive. All eligible transactions will automatically enter the Cardholder(s) into a draw where:

**3 (three) lucky winners will each receive 1 (one) package for Disneyland Paris (the “Prize”). Each package is for 4 (four) persons and includes:**

- ✓ Economy class airline tickets for four (4) persons to Paris (France). The flights are not part of the package provided by Visa and will be covered by the Bank.
- ✓ 3 days in both Disney® Parks for 4 people (Disneyland® Park and Walt Disney Studios® Park) .
- ✓ Disney Premier Access tickets for 2 days
- ✓ VIP Tour for 1 day
- ✓ 2 nights at a Disney Hotel (4 or 5 stars): 1 room with 4 people sharing with 2 double beds
- ✓ Gift cards (total value €1,000)
- ✓ Disney Photo Pass.
- ✓ Private airport transfers to/from Disneyland Paris

2. Each transaction that is carried out by using the Bank's Visa cards will correspond to one (1) entry in the draw.
3. A precondition for a Holder to take part in the draw is to carry out transactions by using the Bank's Visa cards that they hold (debit and/or prepaid and/or credit), for purchases in Cyprus or abroad, during the period 05/01/2026 to 20/02/2026, inclusive.
4. The winning Holders who accept the Prizes are responsible for any expenses, fees, or taxes not expressly stated in these terms and conditions or in any Prize description provided by the Bank and which may arise from the acceptance, possession, or use of any Prize.
5. The prize draw will take place on the 3<sup>rd</sup> of March 2026, unless otherwise announced by the Bank.
6. Holders entered the draw (the “Beneficiary/ies) must provide the correct answer to one question submitted to them, to be eligible to receive their Prize.
7. The following transactions do not qualify for entry into the draw: (a) cash withdrawals; (b) cash or cheque deposits; (c) direct debit payments; (d) bank charges e.g. payment of card subscription fees, fees for re-printing the PIN etc; (e) transactions relating to the payment of taxes and fees for government services (including postage fees); (f) Betting; (g) money transfers and any electronic transfer of money directly to the payment card.

8. In the event a Beneficiary accepts the Prize, then they will be asked for their writing consent to their name and/or place of residence being made public in advertising activities linked to the campaign, in the mass media and/or on social media. Such advertising activities may also include photographic and/or video footage. If the Beneficiary does not consent, the Bank reserves the right to deny handing over the Prize/s.
9. The Bank will contact the draw's Beneficiary/ies by phone or email. If one or more Beneficiary/ies are unable to accept the Prize, or are disqualified according to the terms of this document, or do not receive the Prize due to cancellation of their entry due to non-verification of their eligibility to enter the draw, or due to an entrant not signing the Prize acceptance statement, as detailed below, or due to their being exempt from the campaign, or lastly if the Beneficiary cannot be contacted, or if confirmation of definitive receipt of the Prize is not possible for up to 5 working days from the draw date, the Prize in question will be allocated to the runners-up according to the draw order.
10. When so requested by the Bank, each Beneficiary must submit the original copy of their identification documents, so that the Bank is satisfied and can deliver the Prize.
11. For the issuance of the Prize to the Beneficiary/ies, the Bank will request from the Beneficiary/ies the minimum necessary information required to forward to Visa, Disneyland® Park, Walt Disney Studios® Park and to the travel agency with which the Bank will cooperate for this campaign for the purpose of issuing the Prize and the airline tickets. This information includes full name, identity card or passport number, email address and mobile phone number. Additionally, for the person accompanying the Beneficiary/ies, their full name, identity card or passport number will also be requested to be sent to Visa, Disneyland® Park, Walt Disney Studios® Park and to the travel agency for the same purpose. These data will be deleted by Visa, Disneyland® Park, Walt Disney Studios® Park and the travel agency immediately after the Prize has been issued to the Beneficiary/ies and completed. The Bank will proceed with the deletion of the data of accompanying persons who are not customers of the Bank.
12. The trip must be completed by 30.06.2026.
13. If the Holder terminates their account linked to the Card, they will be drawn for the transactions they carried out prior to the date of termination of that account.
14. Without prejudice to paragraph (1) above, the Prize may not be exchanged for cash or for any other award or gift. The Prize is provided exclusively for the purposes of this campaign.
15. The Bank may disqualify anyone or not allow anyone to further participate in the draw if that person in any way interferes with the participation process or with the smooth running of the draw or acts in breach of these Terms and Conditions.
16. Eligible to participate in the campaign are all Holders who are at least 18 years of age at the time of participating in the campaign. Holders of business cards are excluded.

17. The Bank provides no assurances or representations, nor does it provide any warranties relating to the Prize.
18. The Bank reserves the right to amend these Terms and Conditions at any time, having provided notice which will be communicated to the Holders.
19. If for any reason any part of the campaign or of the draw cannot function as planned due to, inter alia, a computer virus, no network connectivity, unlawful interference, fraud, technical malfunction or other factor that taints or undermines the security, integrity or smooth running of the campaign or the draw, the Bank reserves the right to cancel, terminate, amend or suspend the campaign or the draw, or to cancel any of the affected entries.
20. To the fullest extent permitted by law, the Bank bears no responsibility for any injury, loss or damage to any person or property that may arise, directly or indirectly, in whole or in part, from acceptance of the Prize.
21. The Holders' participation in the Campaign is subject to the absolute and unconditional acceptance of the present terms and conditions.
22. The present terms and conditions shall be governed by the laws of the Republic of Cyprus.
