

TERMS AND CONDITIONS
CARD USAGE CAMPAIGN BY BANK OF CYPRUS PUBLIC COMPANY LTD IN
COLLABORATION WITH FOODY (Delivery Hero (Cyprus) LTD) AND UNICARS LTD

1. Participation in the card usage campaign of Bank of Cyprus Public Company Ltd in collaboration with Foody (Delivery Hero (Cyprus) Ltd) and Unicars Ltd (the “Campaign”) is open to all holders of personal debit and/or prepaid and/or credit cards, whether Visa and/or Mastercard (the “Cards”), issued by Bank of Cyprus Public Company Ltd (the “Bank”), who are permanent residents of Cyprus and have reached the age of eighteen (18) years at the time of participation in the Campaign (the “Cardholder(s)”).

Eligible Cardholders must use their Cards during the period from 06/06/2026 to 02/08/2026 inclusive (the “Transactions”) for purchases made through the Foody platform.

2. Holders of business cards are expressly excluded from participation in the Campaign.
3. Eligible Cardholders will participate in a prize draw conducted by the Bank (the “Draw”) for the following prize (the “Prize”):

One (1) Škoda Kamiq SELECTION 1.0 TSI DSG, including the Selection Plus Package and Assisted Drive Plus, in Brilliant Silver Metallic, with a total value of €27,650, offered by Unicars Ltd.

The above price includes the vehicle registration fees and the registration licence, which is valid until the end of the year of registration. The Prize also includes a five (5)-year manufacturer’s warranty.

4. The Bank reserves the right to exclude any participation and to disallow further participation in the Draw by any Cardholder who interferes in any way with the participation process or the proper operation of the Draw, or who acts in violation of these Terms and Conditions.
5. Each Transaction made using the Bank’s Cards through the Foody platform shall correspond to one (1) entry in the Draw.
6. If a Cardholder proceeds with the termination of their card account, they will participate in the Draw for the Transactions carried out up to the date of termination of that account.
7. The Cardholder selected in the Draw (the “Beneficiary”) must correctly answer a question posed by the Bank in order to be eligible to receive the Prize.
8. The Prize is personal, non-transferable, and may not be exchanged for cash or for any other prize or gift, nor may it be assigned to relatives or third parties. The Prize is offered exclusively in connection with this Campaign.

9. The Draw will take place on 07 August 2026, unless otherwise announced by the Bank.
10. The Bank will notify the Beneficiary by telephone or via electronic mail (email).
11. Upon request by the Bank, the Beneficiary must provide original identification documents satisfactory to the Bank, in order to verify their identity and be eligible to receive the Prize.
12. Any expenses, insurance costs, road taxes, duties or other charges not expressly stated in these Terms and Conditions or in the description of the Prize, which may arise from the acceptance, possession, or use of the Prize, shall be the sole responsibility of and borne exclusively by the Beneficiary.
13. In the event that a Beneficiary is unable, for any reason, to accept the Prize, or if their participation is disqualified in accordance with these Terms and Conditions, or if the Prize is not awarded due to cancellation of their participation in the Draw by the Bank, or due to failure to verify their identity, or if the Beneficiary cannot be contacted, or if confirmation of acceptance of the Prize is not received within five (5) working days from the date of the Draw, the Prize shall be awarded to the alternate Beneficiary, in accordance with the order in which they were selected in the Draw.
14. The Campaign will be valid for the period from 06/06/2026 to 02/08/2026.
15. If the Beneficiary accepts the Prize, the Bank may request the Beneficiary's written and/or verbal consent for the publication of their name and/or city of residence in promotional activities related to the Campaign, across media channels, including mass media (e.g. press, TV) and/or social media of the Bank, Foody (Delivery Hero (Cyprus) Ltd) and Unicars Ltd. Such promotional activities may also include photographic and/or video material. In the event that the Beneficiary does not provide such consent, the Bank reserves the right to refuse the awarding of the Prize.
16. For the purpose of delivering the Prize to the Beneficiary, the Bank shall request the minimum necessary personal data from the Beneficiary to be shared with Foody (Delivery Hero (Cyprus) Ltd) and Unicars Ltd, namely: full name, ID or passport number, email address and mobile phone number.

Such data shall be deleted by Foody (Delivery Hero (Cyprus) Ltd) and Unicars Ltd immediately after delivery of the Prize to the Beneficiary.
17. The Bank reserves the right to amend these Terms and Conditions at any time, subject to prior notification of the Cardholders.

18. The Bank makes no representations or warranties and provides no guarantees whatsoever in relation to the Prize.
19. To the fullest extent permitted by applicable law, the Bank and Foody shall not be liable for any loss, damage, or injury suffered by any person or property arising, directly or indirectly, in whole or in part, from the acceptance, possession, or use of the Prize. By participating, participants acknowledge and agree that the Bank and Foody are fully released and discharged from any and all liability, whether direct or indirect, in connection with the Prize.
20. If, for any reason, any part of the Campaign or the Draw is unable to operate as planned, including but not limited to computer virus infection, network failure, unauthorized intervention, fraud, technical malfunction, or any other cause which corrupts or affects the security, integrity, or proper conduct of the Campaign or the Draw, the Bank reserves the right to cancel, terminate, modify or suspend the Campaign or the Draw, or to invalidate any affected entries.
21. By participating in the Draw, Cardholders confirm that they have read, understood, and agreed to be bound by these Terms and Conditions.
22. These Terms and Conditions shall be governed by the Law of Cyprus.
