

TERMS AND CONDITIONS
VISA CARD – 2026 Euroleague “Final Four” CAMPAIGN
 (the “Terms and Conditions”)

1. Eligible to participate in the Visa Europe Limited (“Visa”) – Euroleague - Euroleague Final Four 2025/2026 (Athens, Greece) campaign (the “Campaign”) are all holders of personal debit and/or prepaid and/or credit Visa cards (the “Cards”) issued by the Bank of Cyprus Public Company Limited (the “Bank”) who have reached the age of eighteen (18) at the time of their participation in the Campaign and who will use their Cards for purchases/transactions in Cyprus or abroad during the period from 16/02/2026 to 19/04/2026 inclusive (the “Transactions”) (except the transactions expressly excluded below) (the “Cardholders”).
2. Holders of business cards are expressly excluded from the Campaign.
3. The following transactions are expressly excluded from the Campaign:
 - (a) cash withdrawals;
 - (b) cash or cheque deposits;
 - (c) direct debit payments;
 - (d) bank charges e.g. payment of card subscription fees, fees for re-printing the PIN etc;
 - (e) transactions relating to the payment of taxes and fees for government services (including postal fees);
 - (f) gambling/betting;
 - (g) money transfers and any electronic transfer of money directly to the payment card.
4. The Bank may exclude any participation and not allow further participation in the Draw to any Cardholder who interferes in any way with the participation process or the smooth operation of the Draw or who acts in breach of these Terms and Conditions.
5. The Cardholders will participate in a draw of the Bank (the “Draw”) for the following prizes (the “Prizes”):

 - Private Airport Transfers A chauffeur will transfer the Beneficiaries to the official hotel and vice versa
 - Group transfers to the Game
 - Visa Events Hosting Team On-Site

From the “Premium Packages” the following are excluded:

- Train, car, taxi, or other travel costs
- Security and medical services
- Any meal, event and/or activity outside of program schedule including transportation
- Translation services
- Athlete appearances
- Guest travel insurance, any applicable taxes; tourist entry visas and passports
- Hotel incidentals (e.g. phone, mini-bar, laundry, etc.)
- Anything else that is not stated as included in the “Premium Packages” described above

B. 7 “Hospitality Packages” (each package for 2 people), consisting of the following:

- Flights to/from Cyprus (will be provided by the Bank)
- “Final Four” tickets (semi-finals and Finals General admission)
- Branded Visa x Euroleague gifts
- Limited edition Visa prepaid card (value €100 per package)
- Visa Events hosting team on-site

From the “Hospitality Packages”, the following are excluded:

- Accommodation
- Train, car, taxi, or other travel costs
- Local activity pass
- Private airport transfers
- Group transfers to the game
- Security and medical services
- Any meal, event and/or activity outside of program schedule including transportation
- Translation services
- Athlete appearances
- Guest travel insurance, any applicable taxes; tourist entry visas and passports
- Anything else that is not stated as included in the “Hospitality Packages” described above

6. Each purchase/transaction executed with the Cards will correspond to one (1) entry in the draw for the Campaign.
7. If a Cardholder proceeds with closure of its account linked to the Card, he/she will take part in the Draw only for the Transactions executed up to the closure date of that account.
8. The Cardholders that will be drawn, will be eligible to receive their Prize, provided that they will answer correctly a question submitted to them by the Bank (the “Beneficiaries”).
9. The Prizes cannot be exchanged for cash or any other prize or gift. The Prizes are provided exclusively, as described above, in the context of the specific Campaign.

11. The Draw will take place on the 28th of April 2026, unless otherwise announced by the Bank.
12. The Bank will notify each Beneficiary by telephone or e-mail.
13. Each Beneficiary, upon request by the Bank, must submit the original documents proving his/her identity, so that the Bank can grant him/her the Prize won.

If a Beneficiary is unable to accept the Prize for any reason, or his/her participation is excluded according to the present Terms and Conditions or does not receive the Prize due to cancellation of his/her entry to the Draw by the Bank or due to non-verification of his/her identity, or if the Beneficiary cannot be contacted or lastly if the Beneficiary’s confirmation of definitive receipt of the Prize is not received for up to 5 working days from the Draw date, the Prize won will be allocated to the runners-up according to the Draw order.

Euroleague - Euroleague Ventures SA is not liable for anything arising out of this promotion including the fulfilment of any Prizes. The Prize must be accepted as awarded and is subject to all of the applicable terms and conditions prescribed to such Prize, which may include passing necessary sanctions screening and entering into a separate waiver. Additionally, for the persons accompanying the Beneficiary/ies, their full name, identity card or passport number will also be requested to be forwarded to Visa, Euroleague – Euroleague Ventures SA and to the travel agency for the same purpose. Visa, Euroleague – Euroleague Ventures SA and the travel agency will delete these data immediately after the Prize has been issued to the Beneficiary/ies and the process is completed. The Bank will proceed with the deletion of the data of accompanying persons who are not customers of the Bank.
