## What is this product?

<b>Type</b>	Over-The-Counter (OTC) Dual Currency Investment
<b>Term</b>	The Maturity Date of the product is 18 April 2024 and it is recommended to hold the product until maturity.
<b>Objectives</b>	<p>To achieve a greater return compared to ordinary bank cash deposits you are accepting foreign exchange risk and the risk of capital loss. 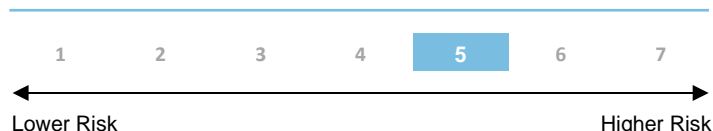
### Intended retail investor

## What are the risks and what could I get in return?

### Summary Risk Indicator



The risk indicator assumes you keep the product until 18 April 2024. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because Bank of Cyprus is not able to pay you. We have classified this product as 5 out of 7, which is a medium-high risk class. This classification takes into consideration two elements: 1) the market risk - that rates the potential losses from future performance at a medium-low level; and 2) the credit risk which estimates that poor market conditions could impact the capacity of Bank of Cyprus to pay you. **Be aware of currency risk. If you will receive payments in a currency other than the official currency of the Member State where the product is marketed, the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.** You are entitled to receive back at least 0.15% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain. If Bank of Cyprus is not able to pay you what is owed, you could lose your entire investment.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.
