These are 3 (three) fields in an agricultural zone in the community of Moutoullas, Nicosia District.

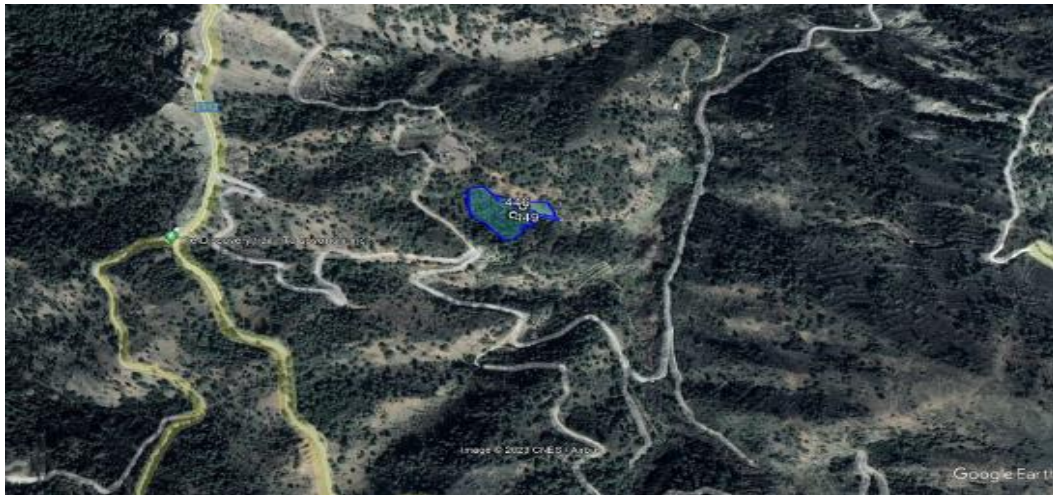
### **Plot 449 and 446 – No. Registration 0/10744 and 0/10745**

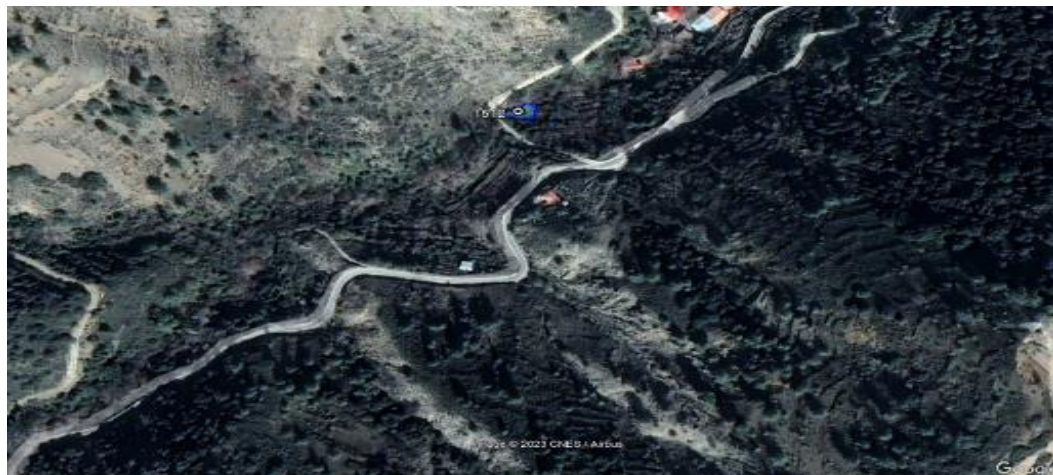
### **Block 1512 - No. Registration 0/10986**
